Benefit installments will be paid in four equal installments. This plan will be offered until February 10, 2015. Motion carried 5-0.

This plan has a cash incentive equal to 70% of the highest salary at Edgewood-Colesburg CSD (excluding substitute wages, overtime pay, extra duty pay.) Each participating employee's benefits will be placed into the Edgewood-Colesburg CSD's Health Reimbursements Arrangement (HRA) operated by the National Insurance Services and MidAmerican Administrative and Retirement Solutions.
