- Math: The 2014-2015 9th grade cohort will increase the percent proficient from 59% in the 2013-2014 to 67% based on the mathematics assessment of the Iowa Tests.
- Science: The 2014-2015 11th grade cohort will increase the percent proficient from 73% in the 2013-2014 to 80% based on the science assessment of the Iowa Test.
