Director Schilling moved to approve the agenda as presented. Motion carried 5-0.

Director Schilling introduced RESOLUTION AUTHORIZING THE REDEMPTION OF GENRAL OBLIGATION SCHOOL BONDS, DATED MAY 1, 2003 AND LEVYING A TAX FOR FISCAL YEAR 2015-2016 FOR THE REDEMPTION OF GENERAL OBLIGATION SCHOOL BONDS, DATED MAY 1, 2003. Director Faust seconded the motion to adopt. Roll Call Vote: Ayes: Schilling, Moser, Moser, Jones, and Faust. Nays: None. President Mescher declared the Resolution adopted.

Director Jones moved to adopt the proposed budget as published and directed the board secretary to certify with the County Auditor and Department of Management the necessary papers as required by law. Motion carried 5-0.

Director Jones moved to accept Superintendent Busch's budget reduction in the amount of \$253,384.56. Mr. Busch's recommendations are as follows: Librarian position will be at .5, reduce elementary art from .8 to .6, hire elementary teacher, bus driver, and high school physics teacher at a lower rate than present, share business manager and human resource director, move 1 hour a day to nutrition fund for elementary and high school custodians, elementary, high school, and administrative assistant secretaries, moved Read 180, .5 elementary and .5 high school counselors to at-risk funding. Also proposed was eliminating after school shuttles for junior high participates. After much discussion, the board decided that this was not a wise decision at this time. Motion carried 5-0.

Director Moser moved to approve the 2015-2016 school calendar. School will start on August 24, 2015 and end on May 26, 2016. Motion carried 5-0.

Director Jones moved to approve the contracts for bus drivers for the 2015-2016 school year. Motion carried 5-0.

Director Jones moved to approve the support staff letter of assignment for the 2015-2016 school year. Motion carried 5-0.

Director Schilling moved to enter into an agreement for participation in the Iowa Association for Educational Purchasing (IAEP) cooperative purchasing program for food service for the 2015-2016 school year. Motion carried 5-0.

Director Jones moved to enter into a 2015-2016 Joint Sharing 28E Agreement with Central CSD for the purpose of sharing Joyce Piorkowski, Business Manager. Motion carried 5-0.

Director Moser moved to enter into an agreement with Mercer Health & Benefits, LLC to provide health insurance coverage through Blue Cross Blue Shield with the Iowa Educators Trust. Motion carried 5-0.

Director Faust moved to approve Shelby Steger and voluntary softball coach pending coaching authorization is received. Motion carried 5-0.
