Director Faust seconded the motion to adopt. Roll Call Vote: Ayes, Schilling, Moser, Mescher, Jones, and Faust. Nays: None. President Mescher declared the Resolution adopted.

Director Jason moved to adopt the proposed budget as published and directed the board secretary to certify with the County Auditor and Department of Management the necessary papers as required by laws. Roll Call Vote: Ayes: Jones, Mescher, Moser, Schilling, and Faust. Nays: None. Motion carried 5-0.

Director Schilling moved to approve the agreement to purchase food service from the Iowa Association for Educational Purchasing for the 2014-2015 school years. Motion carried 5-0.

Director Moser moved to approve the agreement with Timberline Billing Services LLC for medicaid reimbursement for school covered services effective July 1, 2014 and continue through June 30, 2017. Motion carried 5-0.

Director Jones moved to enter into a 2014-2015 Joint Sharing 28E Agreement with Central CSD for the purpose of sharing Jeff Harbaugh, Director of Transportation. Motion carried 5-0.

Director Faust moved to enter into an agreement with Mercer Health & Benefits, LLC to provide health insurance coverage through Blue Cross Blue Shield with the Iowa Educators Trust. Motion carried 5-0.

Director Schilling moved to ratify a one year contract with the Edgewood-Colesburg Teacher's Association. The base salary will be \$28,825.The district's contribution toward health insurance will be \$6,331 and the maximum 403 (b) taken in lieu of health insurance will not exceed \$6,100.00. To the ECA contract \$300 will be added to the base and FBLA will move from Group E to Group D and Athletic Director from Group A to Group K. This is a 3.75% increase. Motion carried 5-0.

Director Moser moved to approve the travel request from FBLA to use school vehicles with them provide funding to cover fuel expenses to attend the National Convention in Nashville, Tennessee on June 28 – July 3, 2014. Motion carried 5-0.

Director Jones moved to go into closed session for the purpose of purchasing real estate at 8:12 p.m. Roll Call Vote: Ayes: Mescher, Moser, Schilling, Faust and Jones. Nays: None. Motion carried.

The board came back into open session at 8:23 p.m.

Director Moser: Attended play and thought everyone did a good job.

Director Schilling: The play was very good and the elementary concert never ceases to amaze us.

Director Faust: Talked to several parents and they thought the elementary concert was awesome.

Director Mescher: Would like to thank Bob Schilling and Paul Wenger for their assistance on the negotiating team.
