## RESOLUTION FOR A GRANT OF LICENSE

WHEREAS, pursuant to notice published as required by law, the Board of Directors of the Edgewood-Colesburg Community School District on the 18th day of December, 2019 held a hearing on the proposal to grant a license across certain real property owned by the District and the extent of objections received from residents or property owners as to said proposed transaction has been fully considered; and, accordingly the following action is now considered to be in the best interests of the District and residents thereof:

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF DIRECTORS OF THE EDGEWOOD-COLESBURG COMMUNITY SCHOOL DISTRICT:

Section 1. That the license described herein shall be granted by the District to Farmers Savings Bank for good and valuable consideration by Solar Power Purchase Agreement.

Section 2. The Board President and Secretary are authorized to sign the Solar Power Purchase Agreement.

Section 3. The Board President, Secretary, Superintendent, and administrative officers of the District are authorized to take all actions necessary to complete the above-described transaction, including execution of ancillary documents.

Section 4. The real property is locally known as 409 East Street, Colesburg, Iowa 52053, and is legally described as follows:

Parcel 2014-29 in the SW  $\frac{1}{4}$  – NE  $\frac{1}{4}$  Section 4 – Twp. 90N – Rge. 3W, City of Colesburg, Delaware County, Iowa, according to plat recorded in Book 2014, Pages 1327; also the North one-half (N  $\frac{1}{4}$ ) of Lot (5) of the Subdivision of the Southwest Quarter (SW  $\frac{1}{4}$ ) of the Northeast Quarter (NE  $\frac{1}{4}$ ) of Section Four (4), Township Ninety (90) North, Range Three (3), West of the Fifth P.M., according to the Amended and Corrected Plat of the Incorporated Town of Colesburg, Iowa, recorded in Book 1 Plats, Pages 73-86.

PASSED AND APPROVED, this 10th day of December, 2019.

Director Venteicher moved to approve the Alliant Interconnection application. Director Elliot seconded the movement. Motion Carried 5-0.

Director Kirby moved to approve submitting request for allowable growth for late open enrollment students in the amount of \$67,360.00. Director Hoeger seconded the movement. Motion Carried 5-0.

Director Venteicher moved to postpone the approval of the Drop-Out Prevention Resolution until the January 2020 meeting. Director Hoeger seconded the movement. Motion Carried 5-0.

Director Hoeger moved to approve offering the certified staff a cash incentive equal to sixty percent (60%), of the highest earned salary at Edgewood-Colesburg Community School District. With the maximum amount of funds available at \$120,000, but may reconsider to meet the needs of the district. This plan is eligible to the employees that meet the Rule of 88 and are at least fifty-five (55) years old on or before July 1, 2020 and have served the Edgewood-Colesburg Community School District for at least twelve (12) years.
