Ed-Co placed 13th this year and received \$400.00 from the school cents program from Lindale Mall in Cedar Rapids.

Superintendent Busch: Thank you to the City of Edgewood for allowing us to park one bus in the fire station wash bay during the extreme cold weather last week. Ed-Co was overpaid \$21,251.22 from the Local Option Sales and Service Tax. The Department of Revenue had a program error which caused this problem. Future monthly payments will be adjusted. There are numerous doors around the secondary building which are experiencing hinge area failures: HS locker room, gym, music room and restrooms. The approximate cost is \$6,510.00.
