Director Schilling moved to approve the K-12 Lau(ELL) Plan for Serving English Learners (ELs) for the 2014-2015 school year. Motion carried 5-0.

Director Moser moved to approve the elementary and high school student handbooks. Motion carried 5-0.

Director Faust moved to approve the depository limits at the Community Savings Bank at 3,000,000 and at Farmers Savings Bank at 1,000,000. Motion carried 5-0.

West Plains Engineering agreement to evaluate mechanical and electrical at the elementary was tabled.

Director Jones moved to approve Rod Varner and Dave Millis as voluntary football coaches and Jill Lueken as voluntary cross country. Motion carried 5-0.

Director Faust moved to approve the 2015 IASB Legislative Action Priorities.

- Supports setting supplemental state aid (replaces the term allowable growth) by
 the date specified in the lowa Code at a rate that encourages continuous school
 improvement and reflects actual cost increases experienced by school districts
 and AEAs. Our priority is to increase the state cost per pupil and the spending
 authority associated with it to build a strong base for future education resources.
- Extend State Penny
- Supports a funding mechanism for school districts' transportation costs that does not directly or indirectly impact funding for the educational program.
- Supports the inclusion of drop-out prevention and funding for at-risk students in the foundation formula and the inclusion of socio-economic status as a factor in determining a student's at-risk status. Supports increased flexibility in the use drop-put prevention and at-risk funding.
- Supports the repeal of the mandatory school start date
- Supports continued progress in the development of rigorous content standards and benchmarks consistent with the Iowa Core focused on improving student achievement, including the following state actions:
 - 1. Provide and fund technical assistance to help school districts fully implement the lowa Core.
 - 2. Develop or obtain high-quality summative and formative assessments, aligned to the skills students should know and be able to do to succeed globally and locally.
 - 3. Include and fund all components of successful standards systems; assessments aligned to high expectations, improved and aligned instruction and quality professional development.
