Director Jones moved to approve the agenda as presented. Motion carried 4-0.

Director Jones moved to not enter into an extended contract with I Jump for natural gas prices. Our current contract will expire in 2016. Motion carried 4-0.

Director Schilling moved to purchase 260 apple computers for high school students and 25 iPad for the elementary not to exceed \$255,000.00. Motion carried 4-0.

Director Faust moved to approve 2015-2016 Administrator Mentoring and Induction Program with School Administrators of Iowa (SAI). Motion carried. 4-0.

Director Jones moved to purchase a 2014 Ford Transit Connect from F. E. Welterlen Motors, Inc. in the amount of \$25,000.00. Motion carried 4-0.

Director Jones moved to approve the William Penn University Student Teacher Agreement for the 2015-2016 school year. Motion carried 4-0.

Director Schilling moved to approve the UNI Student Teacher Agreement for the 2015-2016 school year. Motion carried 4-0.

Director Jones moved to approve Paul Olinger volunteer football coach and weight room coordinator and Dawn Voss for softball. Motion carried 4-0.

Director Schilling moved to invite FEH Associates, Inc., StruXture Architects, and Estes Construction to our June meeting for consideration of hiring a firm for facility improvements. Motion carried 4-0.
